



Consignor Agreement and Release Form

____ Consignor agrees to hold harmless and make no claim against, JoCo Kids Consignment Sale, owners of JoCo Kids Consignment Sale, owner or leaser of the space where the sale is held, any volunteers or paid participants of JoCo Kids Consignment Sale for any damage, theft or loss of any item consigned to JoCo Kids Consignment Sale. JoCo Kids Consignment Sale will take all reasonable precautions to prevent theft, loss or damage. However, consignor assumes the risks of these events occurring.

____ Consignor agrees to waive any and all claims for personal injury which are a result of participating in the sale from any cause against JoCo Kids Consignment Sale, owners of JoCo Kids Consignment Sale, owner or leaser of the location space, any volunteer or paid participant in the sale.

____ Consignor has checked the appropriate agencies (www.cpsc.gov) in determining if there is a recall or a pending recall for any items for sale, JoCo Kids Consignment Sale cannot be held responsible for any items sold at the event that are not deemed safe by the manufacturer or any governing agency pertaining to safety and recalls.

____ JoCo Kids Consignment Sale agrees to pay consignors a base of 65% of items sold during the sale unless otherwise stated. (Referring a new consignor and/or volunteering can earn a consignor up to 75% of items sold.)

____ Consignor understands that items with "FULL-PRICE" in the bottom right corner of the tag will NOT be sold for half-price on half-price day. Items with a D or a blank space in the bottom right corner WILL be sold for half-price.

____ Consignor understands that items may not be accepted, or will be pulled from the selling floor, due to poor quality for one or more of the following reasons: missing pieces, rips/holes/tears, broken, stains, excessive wear, incorrect season, out-of-date, etc.

____ Consignor understands that if a delegate is sent to pick-up unsold items (a signed release will be required for this), JoCo Kids Consignment Sale cannot be responsible if he/she is unable to identify all the consignor's items and/or items are left behind.

____ Consignor understands that checks will be mailed within 2 weeks after the close of the sale. Any checks not cashed within 3 months of the check date will become null and void.

____ Consignor agrees that all items left in the possession of JoCo Kids Consignment Sale after 8:00 p.m. on Monday, Aug 15th, 2016 become the property of JoCo Kids Consignment Sale and may be donated.

____ Consignor will pay a \$10 non-refundable fee assessed to help underwrite costs associated with rent, printing, advertising, etc.

____ Consignor will bring a self-addressed, stamped envelope when dropping off items. Payments cannot be mailed without a SASE.
